- 9. Bid opening shall be on April 1, 2024, 10:15 AM at DOrSU Board Room, Admin Building, Main Campus, Guang-guang, Dahican, City of Mati. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Davao Oriental State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
