## INVITATION TO BID FOR SUBSCRIPTION OF FAIL-OVER INTERNET CONNECTION, MAIN CAMPUS (GOODS2024-09)

1. The Davao Oriental State University through the Special Trust Fund (164) intends to apply the sum of **Two Million Two Hundred Eighty-Four Thousand Eight Hundred Pesos (P2,284,800.00)** being the ABC to payments under the contract for the **Subscription of Fail-Over Internet Connection, Main Campus (GOODS2024-09)**. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The Davao Oriental State University now invites bids for the above Procurement Project. Delivery of the services is required **twelve (12) months** upon receipt of Notice to Proceed. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Prospective Bidders may obtain further information from Davao Oriental State University – Procurement Management Office/BAC Secretariat and inspect the Bidding Documents at the address given below during Mondays to Friday, **8:00 AM to 5:00 PM**.
6. A complete set of Bidding Documents may be acquired by interested Bidders on **May 1-20, 2024** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Three Thousand Pesos (P3,000.00)*. DOrSU allows the bidder to present its proof of payment for the fees both manual or through electronic means.

7. DOrSU accepts payments for the bid documents through bank payment (Landbank of the Philippines) with the following details:

8. The Davao Oriental State University will hold a Pre-Bid Conference<sup>1</sup> on **May 8, 2024, 10:00 AM at DOrSU Board Room, Admin Building** which shall be open to prospective bidders.

9. Bids must be duly received by the BAC Secretariat through manual submission on or before **May 20, 2024, 10:00 am**. Late bids shall not be accepted.

10. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

11. Bid opening shall be on **May 20, 2024 at 10:15 AM at the DOrSU Board Room, Admin Building**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

12. The Davao Oriental State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
