**INVITATION TO BID FOR
SUPPLY, DELIVERY AND INSTALLATION OF MACHINERY AND OTHER
EQUIPMENT UNDER THE ESTABLISHMENT OF LABORATORY EQUIPMENT
FOR THE NEWLY CONSTRUCTED UNIVERSITY RESEARCH, DEVELOPMENT
AND EXTENSION CENTER PROJECT (GOODS2024-08)**

1. The **Davao Oriental State University** through the **GAA (101)** intends to apply the sum of **One Million Five Hundred Fifty-Seven Thousand Pesos (P 1,557,000.00)** being the ABC to payments under the contract for **Supply, Delivery and Installation of Machinery and other Equipment under the Establishment of Laboratory Equipment for the Newly Constructed University Research, Development and Extension Center Project (GOODS2024-08)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Davao Oriental State University** now invites bids for the above Procurement Project. Delivery of the Goods is required by **ninety (90) calendar days**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Prospective Bidders may obtain further information from **Davao Oriental State University – Procurement Management Office/BAC Secretariat** and inspect the Bidding Documents at the address given below during Mondays to Fridays, **8:00 AM to 5:00 PM**.
6. A complete set of Bidding Documents may be acquired by interested Bidders on **May 1-20, 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Two Thousand Pesos (P 2,000.00)** DOrSU allows bidders to present proof of payment for the fees both manual or through electronic means.
7. DOrSU accepts payments for the bid documents through bank payment (Landbank of the Philippines) with the following details:

9. The Davao Oriental State University will hold a Pre-Bid Conference¹ on **May 8, 2024, 10:00 AM at DOrSU Board Room, Main Campus, Guang-guang, Dahican, City of Mati**, which shall be open to prospective bidders.
10. Bids must be duly received by the BAC Secretariat through manual submission on or before **May 20, 2024, 10:00 am**. Late bids shall not be accepted.
11. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
12. Bid opening shall be on **May 20, 2024 at 10:15 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
13. The Davao Oriental State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
