The Davao Oriental State University, through the General Appropriations Act FY 2025 intends to apply the sum of Thirty-Six Million Nine Hundred Thirty-Seven Thousand Pesos (P36,937,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract Completion of Administration Building, Cateel Campus (CW2025-EPA-03). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Davao Oriental State University now invites bids for the above Procurement Project. Completion of the Works is required three hundred twenty (320) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees through manual or electronic means.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.

Bid opening shall be on January 15, 2025, 10:15 AM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Davao Oriental State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
