



**INVITATION TO BID FOR
FINISHING WORKS FOR THE NEWLY CONSTRUCTED
ACTIVITY CENTER AT CATEEL CAMPUS
(CW2025-EPA-02)**

The **Davao Oriental State University**, through the **General Appropriations Act FY 2025** intends to apply the sum of **Fourteen Million Two Hundred Fifty Thousand Pesos (P14,250,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Finishing Works for the Newly Constructed Activity Center at Cateel Campus (CW2025-EPA-02)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **Davao Oriental State University** now invites bids for the above Procurement Project. Completion of the Works is required **two hundred forty (240) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Interested bidders may obtain further information from **Davao Oriental State University – Procurement Management Office/BAC Secretariat** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM excluding Saturdays and Sundays**.

A complete set of Bidding Documents may be acquired by interested bidders on **December 26, 2024 to January 15, 2025** from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (P25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **through manual or electronic means**.

The Davao Oriental State University will hold a Pre-Bid Conference¹ on **January 3, 2025 10:00AM at Board Room, DOrSU, Admin Building, Guang-guang, Dahican, City of Mati, Davao Oriental** and/or through videoconferencing/webcasting, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through manual submission on or before **January 15, 2025, 10:00AM**. Late bids shall not be accepted.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.

Bid opening shall be on **January 15, 2025, 10:15 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Davao Oriental State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
