## INVITATION TO BID FOR PROCUREMENT OF TWO (2) UNITS VAN (GOODS2025-EPA-04)

- 1. The Davao Oriental State University through the General Appropriations Act FY 2025 and as per Authority to Purchase Motor Vehicle (APMV No. DBM-ROXI-2025-002) intends to apply the sum of Six Million Four Hundred Thousand Pesos (P 6,400,000.00) being the ABC to payments under the contract for Procurement of Two (2) Units Van (GOODS2025-EPA-04). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DOrSU now invites bids for the above Procurement Project. Delivery of the Goods is required by one hundred fifty (150) calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from DOrSU Bids and Awards Committee Secretariat/Procurement Management Office and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM excluding Saturdays and Sundays and Holidays.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on November 26, 2024 December 16, 2024 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Seven Thousand Pesos (P7,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person or through electronic means.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before December 16, 2024, 10:00AM. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on December 16, 2024, 10:15AM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Davao Oriental State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
