EXECUTIVE SUMMARY

The year was challenging for Davao Oriental State College of Science and Technology due to the ongoing Covid-19 threat and related restrictions, which affected the College's operations. However, the resilience of all constituents allowed the College to adapt quickly and fulfill its mandate with cheerfulness, consistency, and efficiency.

The College saw 1,353 graduates, a 44% decrease from the previous year. The BSBA program had the highest number of graduates, followed by BS Criminology, while BSN had the fewest. Student population increased by 10.13%, continuing a slight upward trend over the past four years, with more students coming from nearby provinces and beyond.

The faculty comprised 53% full-time, highly competent members. Of these, 29.87% held doctorate degrees, 16.88% were pursuing doctorate degrees, and the rest held or were pursuing master's degrees. Seven students graduated with honors, led by Gabriel C. Modina from the Cateel Extension Campus as magna cum laude. Honor students received Php 30,000.00 (magna cum laude) and Php 20,000.00 (cum laude) for their academic excellence.

The College awarded 484 institutional scholarships and 16,460 externally funded scholarships. Counseling services were used by five students, four in the first quarter. Medical services were provided to 4,754 clients, and dental services to 384.

Library investments focused on developing print and non-print collections and digitizing references. Open access via Facebook and emails was initiated for patron support. The University produced 13 research publications, registered nine copyrighted materials, and presented eight research papers virtually. Six research outputs were utilized within the last three years.

Active partnerships from extension engagements reached 53, with 6,658 trainees and 98 extension programs organized. The University liquidated Php 471,682,739.90 from its NCAs and TRAs. Total assets were Php 1,349,568,050.37, with liabilities of Php 208,810,963.63. Despite a sharp budget decrease, the allocation for 2020 was 126% higher than the previous year. Infrastructure development was a highlight, with early procurement for four civil projects totaling Php 122,911,196.61.

BASIC INFORMATION

Brief History

The Davao Oriental State University (DOrSU) was established in response to the need for quality tertiary education in the province of Davao Oriental. Its inception can be traced back to 1972, when **Hon. Thelma Z. Almario**, then Mayor of the Municipality of Mati, founded the Mati Community College (MCC) per resolution number 22, series of 1972. The College was a local government-run community college located in Barangay Sainz. It offered liberal arts and business-oriented programs. Dr. Leopoldo Bravo, an administrator of the Department of Education, Culture, and Sports, assumed concurrent leadership of the College.

With the goal to expand its operation and provide more opportunities to the residents of Davao Oriental and its neighboring provinces, MCC was converted into Davao Oriental State College of Science and Technology (DOSCST), established on December 13, 1989, by virtue of Republic Act No. 6807. The said conversion was proactively advanced by Hon. Thelma Z. Almario during her tenure as the 2nd Congressional District Representative of Davao Oriental. This newly chartered College started operations in June 1990 with the appointment of **Dr. Julieta I. Ortiz** on May 20, 1990, as its founding president.

In September 1991, the College relocated to a ten-hectare flat land in Barangay Dahican, generously donated by the Mindanao Agro-Pioneers Corporation, owned by the heirs of the late Don Jose Corro Martinez, Sr.

Dr. Jonathan A. Bayogan was appointed as the second college president and served two terms from June 1997 until June 2003. Througout his tenure, extension campuses were established in the adjacent town of San Isidro in November 1997 and in the second northern-most town of Cateel in June 1999. This strategic initiative aims to overcome geographical barriers and ensure equitable opportunities for all to pursue tertiary education.

Dr. Grace G. Lopez succeeded Dr. Bayogan as president. Her term of office started on June 28, 2007, and concluded on June 27, 2011. Throughout her tenure, several significant milestones were achieved, including the installation of a Management Advisory Council in Cateel and San Isidro Extension Campuses, the establishment of an Internal Control Unit to oversee transactions involving government funds, the initiation of administrative policy reforms, and the development of infrastructure to enhance services for students and the community. The College also experienced growth with an increasing rate of student enrollees due to the offering of new academic programs.

Dr. Edito B. Sumile served as the fourth president of the College for two terms starting from February 16, 2012, until January 15, 2020. Under his leadership, an extension campus was established in the Municipality of Banaybanay in June 2015. The physical landscape of the College experienced substantial development with the establishment of numerous buildings and infrastructures across its campuses. In his second term, the College was converted into Davao Oriental State University (DOrSU).

The **Davao Oriental State University (DOrSU)** was established through Republic Act No. 11033, signed into law by President Rodrigo Roa Duterte at the Malacañang Palace on May 28, 2018. Its conversion is an end-product of House Bill 7007 authored by Congress Representative Joel Mayo Z. Almario and Senate Bill 1617 filed by Senator Joel E. Villanueva. President Emeritus Edito B. Sumile successfully paved the groundwork for the University conversion and was sustained by his successor, Dr. Roy G. Ponce.

Dr. Roy G. Ponce was elected as the fifth president of DOSCST on February 19, 2021. It was during his term that the College was officially declared by CHED to be fully compliant with the requirements to operate as a state university. On May 28, 2021, DOSCST was officially declared as a full-fledged university.

With the conversion, the University envisions continually taking part in nation-building by offering advanced technological instruction and pursuing cutting-edge research, extension, and production programs in various fields of science and technology. It played a valuable role in producing professionals and experts who contributed to the advancement of the Davao Region and beyond. Its charter mandates offering of undergraduate, graduate, and postgraduate programs in agriculture and environmental studies, pure and applied sciences, behaviral and social sciences, law, culture and arts, tourism, business, nautical science and maritime transportation, industrial technology, engineering, education and teacher training, communication and information technology, health sciences, developmental management and leadership, and other areas of specialization.




Figure 1. Main Campus Map 2021




Figure 2. Main Campus (Marfori) Map 2021




Figure 3. Cateel Extension Campus Map 2021

The Site Development Plans serve as benchmarks in pursuing orderly growth and physical development in the respective campuses (Figures 1, 2, 3). The maps ensure that the developments are done in a manner harmonious with the surrounding properties and consistent with the welfare of the College constituents and general public.

DORSU's Organizational Structure




Figure 4. San Isidro Extension Campus Map 2021

The DOSCST organizational structure (Figure 4) and the functions of offices therein were revised and later approved in a referendum to the BOT on 24 September 2015. The structure was formulated to address the need to intensify productivity and efficiency of services. The creation of the Vice President for Research, Development and Extension and additional two Directors - Research, and for Extension - highlighted the revised functional structure.

New offices were created, some were just realigned and few were dissolved. There are 55 offices under the revised organizational structure. Whose functions are based on the College Code, RA 8292 and *Batas Pambansa Bilang* 68 known as the Corporation Code of the Philippines.




Figure 5. Banaybanay Extension Campus (Old Site) Map 2021




Figure 6. Banaybanay Extension Campus (New Site) Map 2021




Figure 7. DOrSU Organizational Structure

Annual Physical Report of Operation, 2021

The DOrSU Annual Physical Report of Operation for FY 2021 highlights both commendable achievements and areas for improvement across its Higher Education, Research, and Technical Advisory Extension Programs. While the institution surpassed targets in certain aspects, such as the percentage of first-time licensure exam takers passing exams and the number of research outputs utilized by industries, there are notable shortfalls, particularly in employment rates of graduates and the percentage of undergraduate students enrolled in priority programs. Additionally, while the number of active partnerships resulting from extension activities exceeded targets, maintaining high satisfaction levels among beneficiaries remains imperative. These findings underscore the importance of strategic planning and resource allocation to address disparities, enhance program effectiveness, and align efforts with institutional objectives, ensuring DOrSU's continued growth and impact within its community and beyond.



Conversion as State University Operation Approval

The conversion of the Davao Oriental State College of Science and Technology to a State University was approved into law on May 28, 2018, through Republic Act No. 11033. In Section 23 of RA 11033, compliance with CHED requirements mandates: "The provision of this Act notwithstanding, the conversion of the institution into a state university shall become effective only upon the determination and declaration by the CHED, based on the recommendation of a panel of experts it shall constitute for the purpose, that the institution has complied with the requirements for a university status based on CHED Memorandum Order No. 46, series of 2012. The institution shall retain its status prior to the effectivity of this Act until it is able to comply with the requirements provided herein."

In compliance with the requirements set forth under RA 11033, the Commission En Banc approved the effectivity of the conversion of DOSCST in the City of Mati and all its satellite campuses located in the Province of Davao Oriental into a State University to be known as Davao Oriental State University on May 26, 2021. It was signed by CHED Chairman Dr. J. Prospero E. De Vera III, and Commissioners Dr. Lilian A. De Las Llagas, Dr. Perfecto A. Alibin, Dr. Ronald L. Adamat, and Dr. Aldrin A. Darilag.

PROGRAM ACCREDITATION

As of 2021, the list of accredited programs at DOrSU reveals the institution's dedication to maintaining and improving the quality of its curricular offerings. Table 2 provides a detailed breakdown of each program's accreditation level and its validity period, emphasizing the institution's sustained commitment to high standards. Several programs have achieved Level III re-accreditation, signifying a high level of quality and compliance with rigorous accreditation standards, while others are at Level II or Level I, reflecting varying stages of validation and recognition. Notably, the Bachelor of Physical Education program is accredited at Level I, demonstrating commendable adherence to standards and a commitment to education excellence.




Figure 8. Accreditation Status of Baccalaureate Programs, 2021

Furthermore, recent accreditations for specific programs, such as the Bachelor of Secondary Education (Major in Technology Livelihood Education), Bachelor of Elementary Education (Major in Pre-School Education), and Bachelor of Secondary Education (Major in Filipino), reflect DOrSU's focus on continuous improvement and quality assurance. Figure 8 illustrates the distribution of programs across Levels I, II, and III accreditation, showing that 27% of the programs have reached Level III.

ENROLLMENT TRENDS




Figure 9. Enrollment Trend by Academic Year, 2021

There were 12,821 students officially enrolled in the first semester of school year 2021-2022 from the regularly offered and requested subjects. As compared to the 1st semester of last School year, an increase of number of students for the past five years 17.77% in enrolment was registered. (Figure 9).

GRADUATE TRENDS

For the year, the number of produced graduates of 1,353 was 34% lower compared to that of the preceding year's record. 


Figure 10. Number of Graduates for the Past Years




Figure 11. Distribution of Baccalaureate graduates as to their home town




Figure 12. Tenure of employment of faculty members, 2021

The teaching staff composed of 53% full-time faculty and 47% members part-time reflecting a balance lecturers. between these two categories. Professional development essential for faculty members to enhance their ability to impart relevant, up-to-date knowledge to students and the broader university community. This year, 29.87% of the teaching staff held doctorate degrees, 16.88% were actively pursuing their doctorates, and the rest either held or were pursuing their master's degree, as depicted in figure 12 and 13.

CRIME PREVENTION COMMITTEE

The Crime Prevention Committee under the Office of Student Services advises on crime prevention and campus safety matters affecting DOrSU populace. The committee also provides leadership in adopting and promoting a comprehensive, inclusive approach in crime prevention by addressing causes of crime and disorder in campus. The objective is to identify new approaches or models for campus safety and well-being, transfer these knowledges and advocate better understanding of crime prevention, advance on emerging issues on campus crime and encourage outreach and education to garner support for crime prevention, campus safety and security.

In 2021, and because of the current pandemic, the CPC extends its services though social media platform, preferably Facebook Page and Facebook Messenger. The service offered is centered on crime prevention tips, promotions and counseling on complaint and referral to responsible authorities (e.g., PNP, DSWD) when the situation warrants.

The table below shows the accumulated reached/viewed publications posted as part of the service rendered by the committee particularly crime prevention information dissemination through social media for wider audience.

In 2021, notable accomplishments included the creation of a university-wide video on General Safety & Crime Prevention Tips and the establishment of the CPC Facebook Page to disseminate crime prevention information. The unit actively participated in the 27th Crime Prevention Week and Drug Abuse & Prevention Control Week, conducted regular security and safety inspections across all campuses, and strengthened ties with the Davao Oriental Provincial Police Office by joining its Advisory Council. Additionally, firearms proficiency training was provided to DAS-SSU personnel, and the unit engaged in ODAS pre-planning activities, presenting their annual plan for review. Routine functions such as consultancy and referrals for criminal cases, bullying, cyber-bullying, and sexual harassment were also diligently executed, although no formal complaints were reported.

FINANCIAL ASSISTANCE, SCHOLARSHIP AND STUDENTSHIP

The institution remains deeply committed to making education accessible to all, particularly to students in need, through various financial support programs. This dedication is evident in the comprehensive range of grans and scholarships provided for the AY 2020-2021, both internally and externally funded. Tables 6, 8, and 10 highlights the number of students awarded grants/scholarships campus, detailing their specific sponsors and classification. In addition, Tables 7,9 and 11 offers a cost breakdown of these scholarship per semester, underscoring the significant financial assistance extended to ensure that more students can pursue higher education without financial barriers.

HEALTH SERVICES UNIT

The Health Services Unit is an arm of the Office of Student Services Division that provides health services to the DOSCST constituents within the framework of the Clinic-Out-Patient setting and referral system as the need arises. This involves consultation, treatment of health-related problems, and referrals.

This 2021, the Health Services Unit extends its services through telehealth with the use of FB messenger, text messaging, and call. The services offered include consultation either walk-in or via online, Blood pressure taking, wound dressing, Random Blood Sugar, and Issuance of Medical Certificates.

The table below shows the services rendered/availed by faculty, staff, and students for this year 2021 also extended its services by monitoring those employees who were home quarantined. A total of 4,373 times medical services and procedures availed/rendered for 2021.



LIBRARY SERVICES

Following a period of adjustment to the new normal setting, the operations and services of the university library began to shift in order to gradually enter the emerging SMART Library trend. Aware of the university's Smart Infrastructure, implementation of such will soon boost full online library information service.

Looking at how the library has done so far this year, the following highlights have had a significant impact on efficiency, allowing the administration to run smoothly in terms of quality compliance.

First Quarter. The library staff convened in the first quarter of 2021 during an internal meeting conducted by the Library Director. Matters about renewal, resignation, blocking of assignments in a skeleton set-up, plans for the year, needed supplies and inventory results were tackled.

Some highlights of the period included the preparation for CHED RQAT compliance, admin online meetings and trainings, accreditation training on E-file management, a finalized proposal for furniture and fixtures, a revised organizational structure of the library, webinars, linkages meetings such as PLAI, and MASTSLinet, issued duties and functions of staff for Jan-June 2021, and a turnover and blessing of the 3-storey library building.



Second Quarter. The highlight was on the COPC verification in compliance to university hood. The library was able to produce the necessary documents and enable the availability of a library website, where OPAC for Destiny and Koha Systems, EBSCO, OER's and other online databases can be easily accessed and retrieved. Google Drive was also explored being highly used to keep scan books and send documents online. Moreover, the Mindanao Association of State Tertiary Schools, Inc., (MASTSLinet) held their 6th Annual General Assembly meeting and Conference on May 18-20, 2021 in order to maintain linkages and network.



Third Quarter. When the university implemented a mostly work-from-home schedule and a granular lockdown during the period, library staff felt the strain. Work tasks performed in an office setting have unquestionably left behind, particularly in the technical services section, which handles cataloging, inventory, resource acquisition and digitization. Much after the Internet connection's two-year contract had expired. Regardless of the situation, the library staff maintains its focus on online circulation delivery via social media platforms and its website. Skeleton duty had been implemented to slowly offer the services demanded by customers. Specifically, the following were achieved during the period.

Since the beginning of the first quarter, the university has placed a strong emphasis on accreditation preparation. Gantt charts and online reporting have been completed in order to prepare each unit, particularly the Quality Assurance Office, for the first online accreditation. A series of trainings and meetings were held, with the emphasis on Google Drive manipulations, where to upload documents, and so on. The final accreditation survey for three Education Programs (BSED-TLE, BSED-Filipino, BEED/BCED) was held from November 15 to 19, 2021. During the exit conference, Dr. Liza Tamargo, the Librarian-Accreditor from Ifugao State University, expressed a positive outcome and recommendations.

On November 29, 2021, the DOrSU Library held an event to celebrate National Book Week and Library and Information Services Month with the theme "Libraries Building Roads: Readers, Opportunities, Advocacies, Development, Sustainability." The theme emphasized the importance of improving and collaborating on library services to meet patrons' information needs and support academic performance, research, and education.

As part of the event, an online training session was conducted for DOrSU librarians and staff. The training covered cataloging according to CHED CMO 22, series of 2021, networking with extension campus libraries, the role of information literacy in academic success, and office ethics. Dr. Evangeline Rivera, Director for Student Services, represented the VP for Academic Affairs, encouraging the continued effort to meet patrons' information needs. This in-house training marked the third activity under the Library and Staff Development Program (LSDeP-3), launched in 2019. The library extends its gratitude to President Dr. Roy G. Ponce for supporting this initiative.

ANNUAL ACCOMPLISHMENT 2021

In terms of developing collections, organization, and preservation functions, the library had continuously improved resources by acquiring an EBSCO subscription that included e-books/e-journals collections that supported references for the various programs. There were notable donors in a print book and journals as well, particularly from various donor agencies.

Library transactions were mostly done online in the new normal, making Digital Document Delivery services more active and accessible. The following services were also kept: pre-booking and pick-up. Ask-a-Librarian via DOrSU Lib's Facebook account, email account to send digitized books in view-only mode via Google Drive, clearance signing, answering to online appointment, and so on.

The library has created a code or highlighter for its Facebook account called (Acquinew) for new reference acquisitions and (Infonew) for updates to library operations and services. Some of the library's active donors, gift and exchange partners, and individual supporters provide consistent support, thereby maintaining the linkages and networking activities. Journal publication of DOrSU was also sent to 7 SUCs in Mindanao for gift and exchange. Reflected below are screenshots of the donors posted at the DOrSU Lib FB account.



MANAGEMENT INFORMATION SYSTEM


The Management Information Service (MIS) Unit is vital in an organization which is a part of a bigger system whose orientation focuses on more efficient and effective delivery of organized information.

The goals set for the year were for a judicious and accurate response to the informational needs of the University internally and externally, and an improved and refined mode of recording and aggregating information.


INFRASTRUCTURE OFFICE











